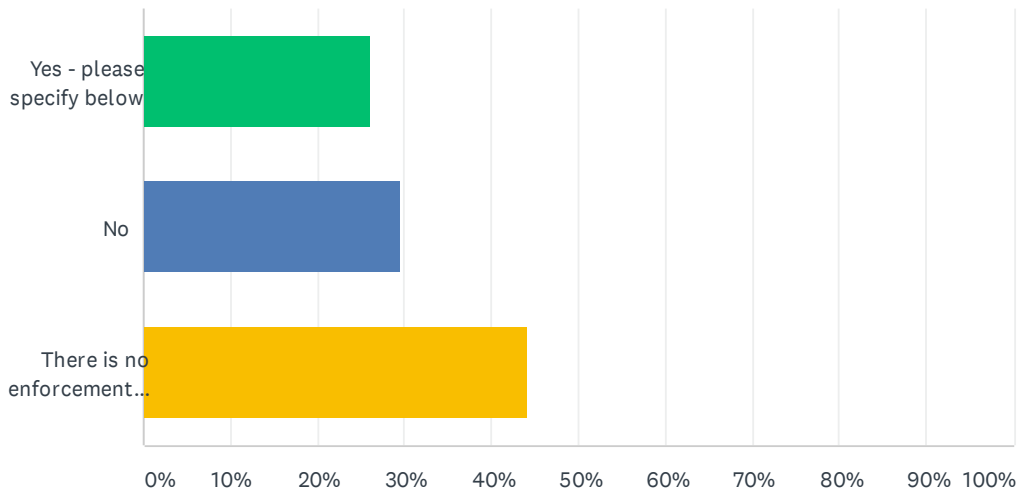


Q3 In your company, do you know who is responsible for enforcing social distancing and face coverings on bus services?

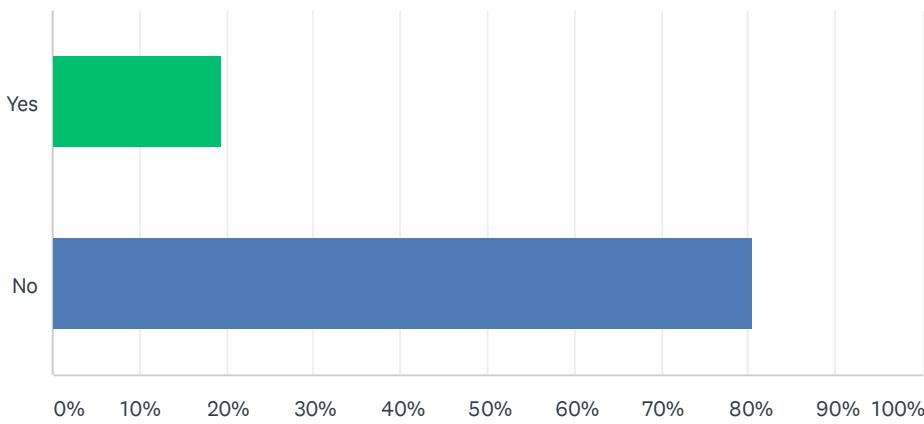

Q4 In your company, do you think there is adequate enforcement of compliance with face coverings on bus services?

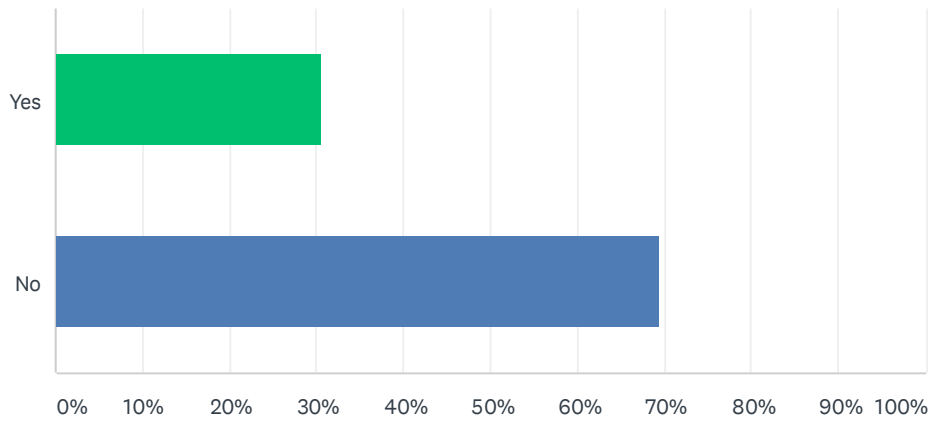

Q5 In your company, do you think there is adequate enforcement of social distancing on bus services?

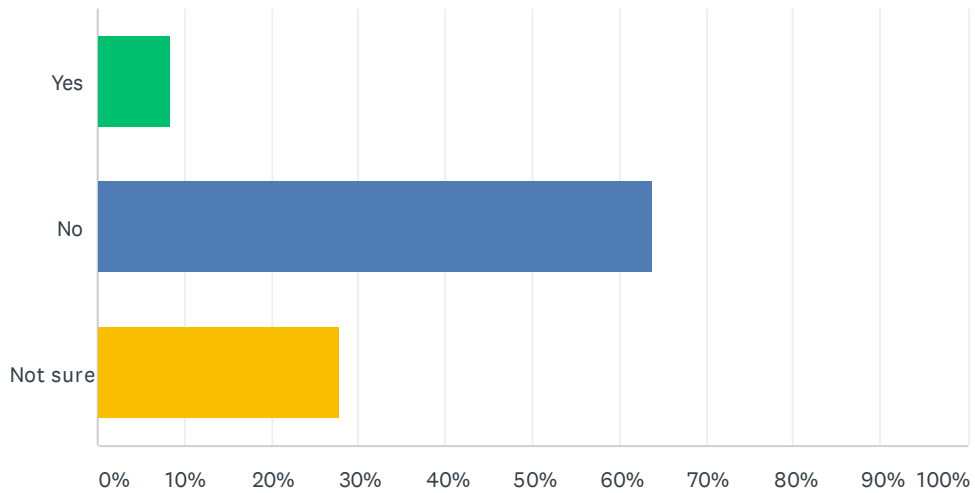

Q6 Do you think enforcement of social distancing and face coverings is treated as seriously on the bus network as it is on the rail network?

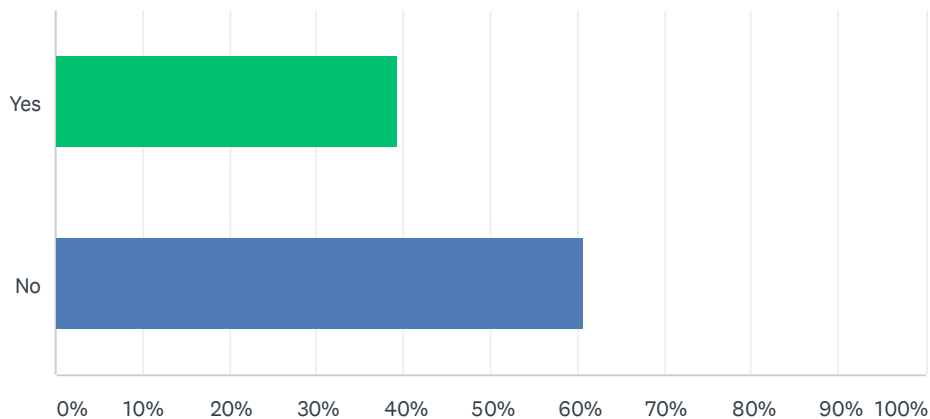

Q7 Since the emergence of the more infectious variant of Covid-19, has your employer taken additional steps to protect staff safety? Please give details.

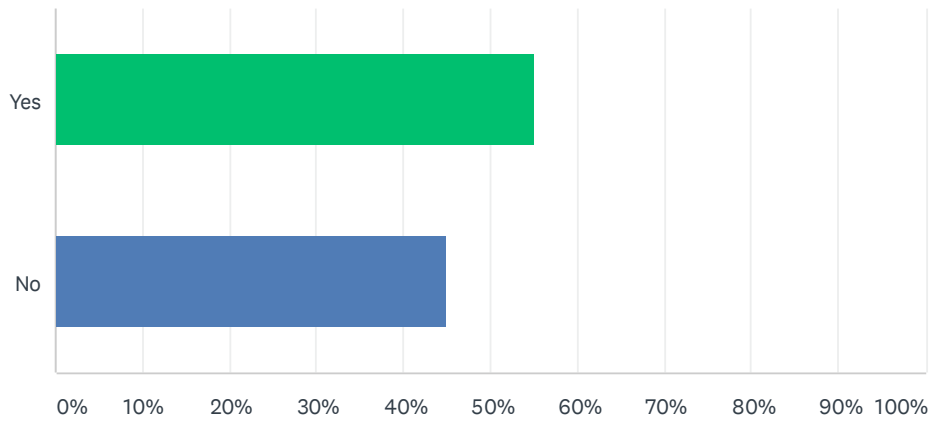

Q8 Is your employer currently providing you with adequate washing facilities at work and/or are washing facilities available on your route?

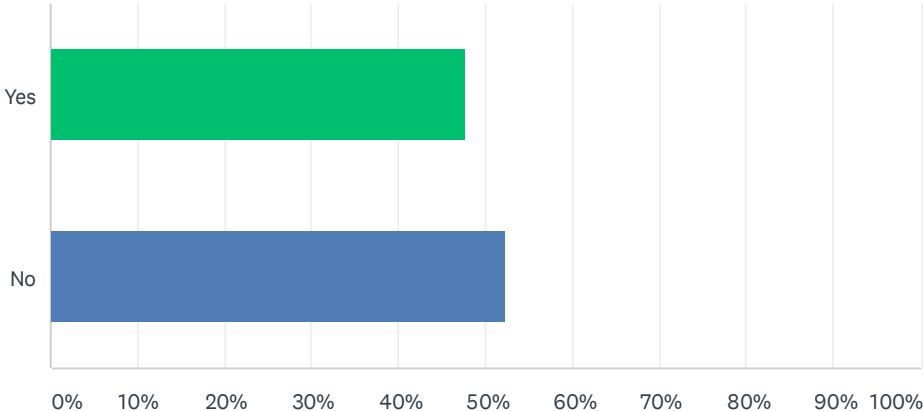

Q9 Has your employer put provisions in place to allow for cashless travel?

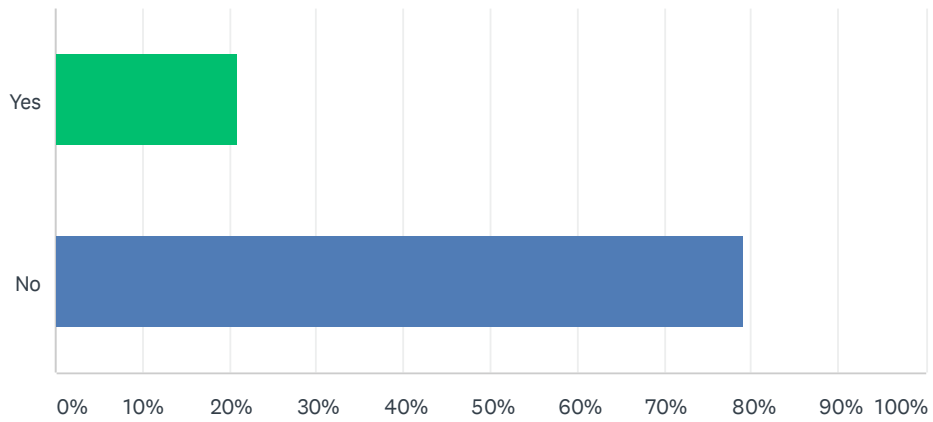

Q10 Has your employer introduced an exact fare policy to minimise cash handling?

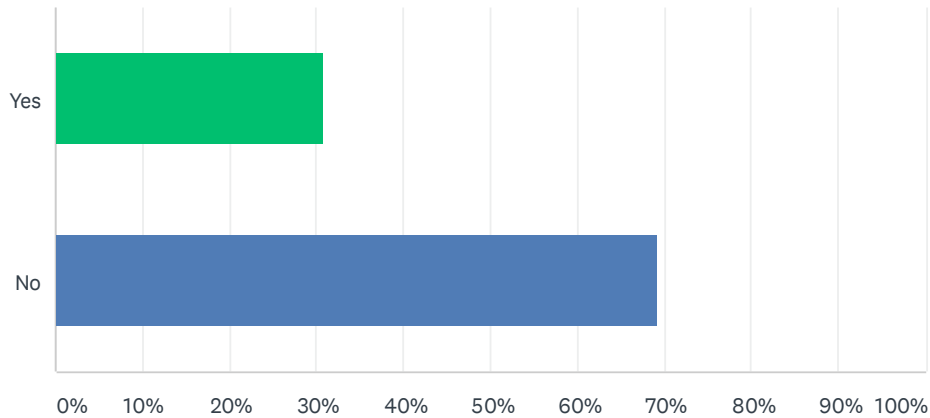

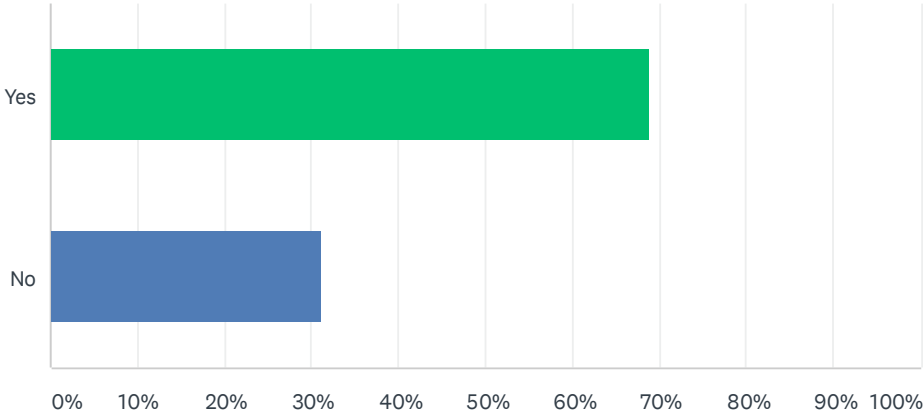
